Test Method:  
The lens shall be placed mechanically centered, convex side up, on the test block of an anvil composed of the parts shown in Figure 22, mounted in the hole of the base plate, the whole assembly on a flat, horizontal work surface of convenient height. A 25.4 mm Dia. steel ball, weighing approximately 68 grams shall be dropped in free fall from a height of 1.27 meters (50 in) onto the horizontal outer surface of the lens. The lens shall not fracture in this test.
